HOW TO STOP ENDLESS WAR: AN APPEAL TO THE PEACE MOVEMENT

Below is a plan on how to stop the fraudulent,"war on terror" which is used to continue wars for oil and hegemony, creating a vicious cycle indefinitely until the last drop of oil is pumped. The proxy fight in Syria over who will obtain the oil pipeline route to European markets is in real danger of spinning out of control to become a nuclear war with Russia.

This proposed plan is based on information and analysis of Maryland attorney Barry Kissin in his three-part series THE TRUTH ABOUT THE 28 PAGES AND ITS ENDURING COVER-UP as footnoted below. These articles have been summarized in a much shorter outline by Richard Ochs here.

APPEAL TO THE PEACE MOVEMENT

Contrary to some corporate media that the 28 pages does not prove Saudi government complicity with the 9/11 attacks, below is proof that the 28 pages confirm other reports that there was Saudi-U.S. collusion in causing the 9/11 attacks for the purpose of starting the Global War on Terror (GWOT) aka wars for oil, pipelines and hegemony. Unless the anti-war movement embraces and disseminates this truth, we will have endless war and possibly nuclear world war. We can no longer just demonstrate for peace. We must study the reasons for endless war and educate the population accordingly.

The recently released 28 pages of the 2002 Joint Congressional Intelligence Committee report on the 9/11 attacks (not to be confused with the flawed 9/11 Commission report of 2004) gives enough evidence that, if presented in a court of law, would likely convince a jury that the Saudi government financed and arranged support and flight training for at least two of the named hijackers of flight 77, said to hit the Pentagon. The peace movement would be remiss not to join former Commission members, members of Congress and 9/11 families in their demand for a new investigation and indictments.

Mr. Kissin cites page numbers of the 28 pages of the 838 page Congressional report which were suppressed for 14 years and released this July only after 66 members of Congress, 9/11 family survivors and protestors demanded it, aided by TV coverage by Frontline and 60 Minutes.

These 28 pages state that then-Saudi Ambassador to the U.S., Prince Bandar bin Sultan and his wife sent \$100,000 to Saudi agent Bassnan in San Diego, who lived across the street from the two named Saudi hijackers. A long-time colleague of Bassnan named Bayoumi, receiving money from the Saudi Ministry of Defense, paid the rent for the same two named hijackers for 18 months before 9/11/01 attacks. He paid for a translator for them because they did not speak English and arranged flight school for them. Bassnan told an FBI asset that he did more for the two named hijackers with the \$100,000 from Prince Bandar than did Bayoumi.

Senator Bob Graham, former chairman of the Committee whose 28 pages were suppressed by Presidents Bush and Obama, stated that the 28 pages show a "cover-up," "aggressive deception," "FBI statements untrue," and "the Saudi government was a co-conspirator in 9/11."

Kristen Breitweiser, who lost her husband to the 9/11 attacks, and four other 9/11 widows issued a press release stating "...when you listen to any member of our government state that the newly released 28 pages are no smoking gun – THEY ARE LYING." Their statement continued: "Zelikow blocked and then fired Dana Lesemann when she tried to investigate the uninvestigated leads in the 28 pages." Philip Zelikow was the Bush-appointed head of the 9/11 Commission. The New York Post reported that Zelikow blocked subpoenas of Saudi suspects and was thereafter made senior advisor to the Secretary of State Condoleeza Rice. Three members of Zelikow's Commission have since admitted that the Saudis were not adequately investigated by the 9/11 Commission.

The 9/11 widows statement concluded: "The kingdom of Saudi Arabia provided operational and financial support to the 9/11 hijackers. That is a fact. And, the U.S. Government has been covering up that fact for 15 years – even to this very day. And that is a crime."

Mr. Kissin's 3-part series ends by referring to a 2006 New Yorker magazine report that the two named hijackers financed by Prince Bandar and the Saudi Ministry of Defense, managed by Saudi agents Bassnan and Bayoumi were protected by the CIA prior to 9/11/01: "...the CIA's deliberate concealment from the FBI of the fact that two important members of al Qaeda were in the U.S. over a period of 18 months leading up to 9/11." The CIA underlings who were directly involved in this concealment were thereafter promoted instead of being held accountable.

Prince Bandar, also called "Bandar Bush" due to his intimate friendship with the Bush family, has a long history of doing the bidding of U.S. imperialism. Bandar organized the Mujahedeen precursors to al Qaeda to attack the elected government in Afghanistan, financed the terrorist Contras during Poppy Bush's Iran-Contra operation, and most recently was coordinating the terrorists' effort to topple Assad in Syria (Wall St. Journal, Aug. 25, 2013). As Senator Bob Graham has stated: "Al Qaeda was a creature of Saudi Arabia; ...and now, ISIS is the latest creature . . . a product of Saudi ideals, Saudi money, and Saudi organizational support." 9-11 is one of a series of roles for Bandar that all amount to deploying terrorists on behalf of the Saudi-American military-intelligence alliance.

HOW TO STOP ENDLESS WAR

1. Correct the disinformation that the U.S. is fighting ISIS, ISIL, al Qaeda, al Nusra, Lavant, Daesh rebels. It is a Hitlerian BIG LIE because the U.S. ally Saudi Arabia is supporting these rebels financially, ideologically, materially and historically. U.S. corporate media with CIA liaisons, including the Washington Post and NYT, which repeated the lies that

got us into Iraq, continues to slavishly repeat this lie every day with no investigative journalism. These rebels use U.S. weapons and export petroleum to the U.S. ally Turkey.

- 2. Cut off all U.S. military exports to Saudi Arabia, Qatar and Turkey.
- 3. Stop trying to overthrow the legal government in Syria and other countries.
- 4. Expose the Saudi government role in the 9/11 attacks in the U.S.

Of these 4 objectives, we should start with #4 because:

- 1. Mass media has already reported on opening the 28 pages (Frontline and 60 Minutes).
- 2. Congress has overridden Obama's veto to allow 9/11 families to sue Saudi Arabia based on information in the 28 pages.
- 3. The public is disgusted by Saudi human rights violations, the world's beheading capital.

- 4. Build membership in a "28 pages Truth Coalition"

- 8. Banner at the White House and Capitol Hill: "Expose Saudi role in 9/11"
- 9. Lobby Congress to expose Saudi role in 9/11
- 10. Hound officials to expose Saudi role in 9/11
- 11. Give hand-outs at all demonstrations.
- 12. Publish social media articles.
