Hundreds of 9/11 Families File Lawsuit Against Saudi Arabia

The lawsuit filed on Friday accuses Saudi Arabia of funding and providing logistical support for al-Qaida terrorist activities, funded Afghan terrorist training camps, and provided material support for the 9/11 terror attacks on the U.S. The claims are for personal injury and wrongful death; damages are unspecified.

The lawsuit's plaintiffs are hundreds of families of 9/11 victims (135 pages of them, to be exact) against one defendant – the Kingdom of Saudi Arabia. The lawsuit is the first of its kind, recently authorized by the **Justice Against Sponsors of Terrorism Act (JASTA).** Until now, civil lawsuits naming foreign nations as defendants were just about *always* thrown out of federal because the doctrine of "foreign sovereign immunity" acted as an absolute shield against plaintiffs.
